Biscuits Outing:

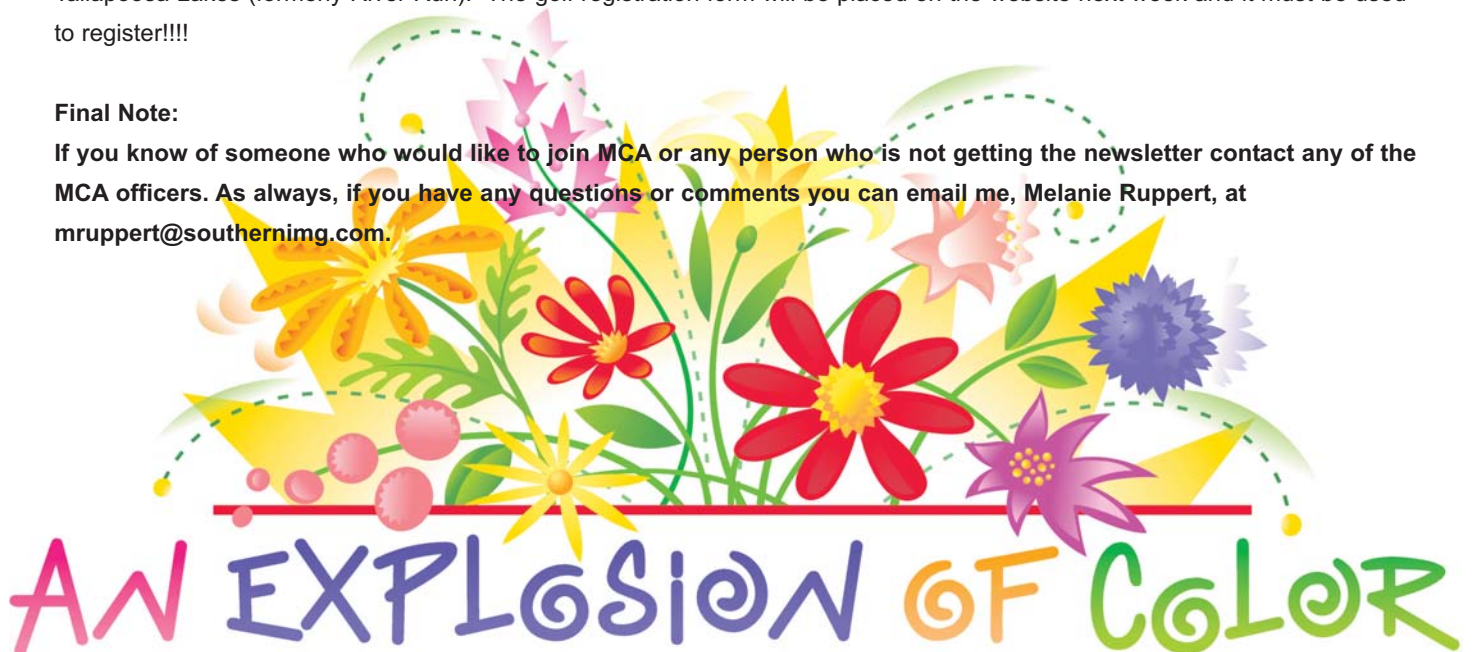
