Larry has been slotted for 1 hour and will speak on the topic of some insurance adjusters taking the Uniform accident reports at face value, instead of investigating and getting to the actual facts of the accident. Sometimes the reports are NOT right and it should be kept in mind that the Acc. Reports are only the OPINIONS OF THE INVESTIGATING OFFICER. Larry was an M.P.D. officer for 14 years, leaving there in 1985 and starting his own business in Accident Reconstruction and Investigations. He has investigated and/or reconstructed over 12,000 accidents and testified as an expert witness in Federal, State and local courts in excess of 500 times. He also is, by Contract, with my employess, Chief Investigator for the Alabama Department of Transportation, working strictly out of the Transportation Director's office. They do all Reconstruction and Investigations for ALDOT and all 5,000 employees. This is in addition to the Accident Reconstruction and investigations for Private Attorneys, Insurance Companies, and private companies. They also consult with trucking companies and handle safety for them. Larry has also worked with the NTSB on the Huntsville, Al school bus accident in 2006 and works constantly with most all state, federal and local law enforcement agencies.
