Volunteers go out into these communities and address cardio-metabolic risk factors (high blood pressure, high cholesterol, diabetes, obesity and tobacco use) that disproportionately affect underserved populations. Our donations will help to buy supplies and or help with upkeep on the mobile units that go out to these areas to provide this great service. 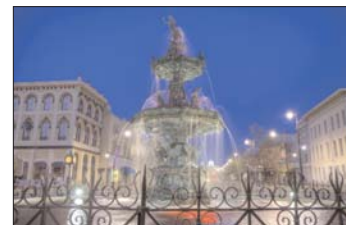
